GOOD CONDUCT POLICY FOR EXTRACURRICULAR ACTIVITIES

Roosevelt Middle School offers a wide range of extracurricular and intramural activities. It is a privilege to be able to participate in these activities. Participation in these activities complements each student's education by promoting good citizenship and moral character, developing skills necessary to personal success and well-being, including taking responsibility for personal actions.

~Students who participate in any extracurricular activities are expected to do their PARRT (see attached list of expected behaviors) and to represent the school and the community in an appropriate manner. A student participating in extra-curricular or intramural activities shall be required to follow the established rules and regulations set out in this policy while on school grounds, school district property, property within jurisdiction of school district while attending or engaged in school activities, or in any way representing Roosevelt Middle School.

Applicable Activity Programs

The good conduct policy applies to all extracurricular and intramural activities, including but NOT limited to:

1. All athletics
2. All music/vocals/drama, and dance team
3. All school clubs/organizations

Any team or activity sponsor/coach may have rules and regulations in addition to this policy which must be adhered to as well. These will be above and beyond what is listed here and will be monitored by the coach/sponsor.

Acknowledgement of Good Conduct Policy

All students and parents/guardians will receive the good conduct policy and be responsible to read, sign and return the eligibility agreement. Failure to sign will exclude the student from any participation. Students will have one calendar week after an activity begins to turn in a signed Eligibility Agreement. Any violations of this policy will be governed by the Good Conduct Policy regardless of the date of signing the Acknowledgement of Good Conduct Policy.

Roosevelt Middle School Good Conduct Expectations

The following positive behaviors are examples of how students participating in extracurricular activities will follow PARRT expectations before, during, and after the school day. The student:

Personal Best

- ~is on time to class
- ~has work completed on time
- ~asks for help when needed
- ~gives their best effort/continued effort

Active Listening

- ~is attentive in class
- ~takes notes when asked
- ~begins assignments/activities when directed
- ~follows directions the first time given

Respect

- ~responds appropriately
- ~behaves appropriately
- ~keeps hands and feet to self
- ~shows respect for others

Responsibility

- ~brings appropriate materials
- ~has homework/activities completed
- ~is helpful to others

Trustworthiness

- ~is in assigned area at all times
- ~keeps out of others' things
- ~does their own work
